
The meeting decided that the D-8 TTEN Secretariat will prepare the prerequisites to act as D-8 Technology Transfer Center (TTC) in order to facilitate technology transfer among the Member States. The D-8 TTEN, in close liaison with the D-8 Secretariat, will develop the criteria for cooperation and report to the next meeting.

#### 5<sup>th</sup> HCM

With regard to the current situation of the D-8 TTEN, the number of technology offers and requests being posted on the D-8 TTEN website needs to be increased in order to have more matchmaking opportunities.

The Secretariat explained that the D-8 TTEN Technology Transfer Award has been proposed by I.R Iran in the 2nd High Council Meeting of D-8 TTEN and was emphasized on it in the 3rd High Council Meeting of D-8 TTEN, Malaysia, in December, 2015. Terms of Reference Establishment and Management of D-8 Technology Transfer and Exchange Network (D-8 TTEN)

#### **Preamble:**

Considering the special capacities of the D-8 Organization for Economic Cooperation, one of the most important steps towards achieving the position explained in the D-8 2030 strategic document is to pave the ground for developing technological cooperation between member states.

Following the meeting of the D-8 senior officials in the second meeting of industry ministers on October 5, 2011, in Istanbul, Turkey, the D-8 technology transfer and exchange network proposal called D-8 Technology Transfer and Exchange Network (D-8 TTEN) was introduced by I.R. Iran's Pardis Technology Park.

Also, the plan to establish a network in the working group on technological cooperation was approved by the countries and finally, the meeting of the Ministers of the Organization was held on October 9-10, 2012 in Dhaka, Bangladesh, and the D-8 TTEN has been launched.

D-8 TTEN is an information and exchange network between member states, which is responsible for creating the convergence and synergy between the D-8 member states through capacity building and informing about the achievements and needs of technology and organizing technology exchanges.

Paving the ground requires the creation of a structure for establishing interaction and sharing cooperation and information contexts concerning the supply and demand of technology and technological products, and ultimately the creation of synergy among all active factors in these fields among D-8 members.











